likewize.

 - a. they have sole responsibility for keeping a separate backup copy of any files or data before transferring ownership of the Eligible Device to Likewize, and that they have taken reasonable steps to remove files and data that are deemed personal or confidential. The Recycling Service does not include data recovery. Apple and Likewize accept no responsibility or liability for lost files or data;
 - b. they are responsible for ensuring the SIM card and any accessories are removed from the Eligible Device, and agree that Likewize and Apple are not responsible for any costs arising from their failure to remove the SIM

- c. they must provide two forms of original proof of identity items that together show Customer's full name, photograph, current address, date of birth and signature;
- d. it may be legally necessary to provide to law enforcement the unique numeric identifier of the Customer's product and the Customer's personal information as provided under this Recycling Service;
- e. to the extent permissible by law, they indemnify Apple and Likewize and any of their directors, officers, employees, affiliates, subsidiaries or agents from and against any claims brought against any of them arising from performing this Recycling Service, or for any breach of these terms and conditions by the Customer.

- 12. To the extent permissible by law, Likewize and Apple will not be liable for any special, indirect, incidental or consequential damages resulting from the Recycling Service. To the extent permitted by law, Likewize's and Apple's entire liability, if any, from any cause whatsoever with respect to this Recycling Service shall not exceed \$50.
- 13. The Recycling Service is void where prohibited or restricted by law and may not be available in all Apple locations.
- 14. To the extent permissible by law, Likewize and Apple reserve the right to refuse, cancel or limit Recycling Services for any reason.
- 15. The Recycling Service is not redeemable and has no cash value.
